2 Continued Discussion of Teaching forms

Questions have been raised by several faculty members about both the administration and the content of the form The discussion of content still focuses primarily on the *summative vs. formative* nature of the questions. When the committee met to create the form they were preparing a *formative* evaluation tool. VC Patton has repeatedly confirmed that she does not use the current form to generate a single number that can be used to rank faculty. The form is not and should not be used summatively. Instead the Promotion and Tenure committee are most concerned about the general trend of the evaluations with evidence of improvement in areas of concern.

The Math Department has actually generated its own approved evaluation form, by removing questions from the general form that were not pertinent to good math pedagogy. Susan Leland offered to email a copy of their form to Senate members. Andrea will also email a copy of the 41 question form to Senate members before the next meeting.

3. Possible deferral of CEO pay increase until October 2007

Chancellor Gilmore had asked President Dennison if he could defer his pay raise until October 2007. The legislature does not meet this Spring so there is no mechanism for the state to allocate more funds to cover the cost of substantive pay raises to CEO's. President Dennison left it up to Chancellor Gilmore to decide whether or not to defer his raise. Chancellor Gilmore commented that he was willing to defer his pay raise until 2007.

4. Informational Items

Susan Leland reported the formation of a Montana Tech Phi Theta Kappa chapter. This is an honor society for two year colleges. She thought Montana Tech might also consider the formation of the comparable four year college honor society, Phi Beta Kappa.
